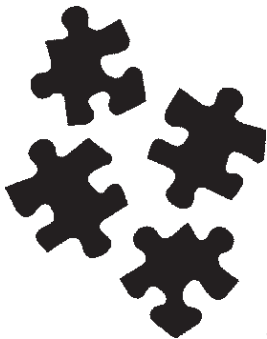




## Complete the Picture with the Franklin Solution

Most accounts can be closed quickly and easily with the forms that follow. Some accounts, such as checking, require a little more planning.

### Checking Checklist

**Open New Checking Account:** We'll order your checks and ATM card, both of which will be delivered in about two weeks.

**Re-Direct Deposits:** Identify every source for your direct deposits and fill out a Re-Direct Deposit form for each one. Payroll and Social Security checks are common items that may be directly deposited.

**Automatic Debits:** Do you have any of your bills paid automatically from your account? Common types of automatic debits are utility bills, health club dues, insurance premiums and loan payments. Use the Automatic Debit Change form for these.

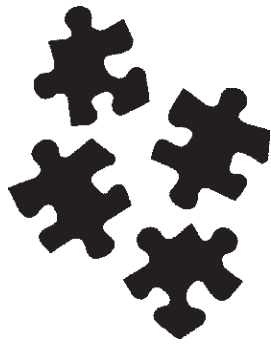
**Internet Bill-Pay Service:** If you have signed on with an Internet bill paying service, you will want to make sure to change your financial institution, add your new account and delete your old account. This can be done quickly online at your account setup screen. Our Routing Number is 211274492.

**Letting the dust settle:** Most of your checks and ATM/Debit card transactions should clear within a couple of weeks. Be sure to check your statement to make sure all have cleared before closing your old account. Again, enter this information on the Account Closure form and let us know when it's time to send the form to the old financial institution.
